
BOTANY RAIL DUPLICATION

PROJECT UPDATE | SUMMER 2020



WE'RE ON TRACK TO DELIVER CRITICAL FREIGHT RAIL IMPROVEMENTS. AS SYDNEY'S POPULATION AND FREIGHT TASK GROWS, THE BOTANY RAIL DUPLICATION WILL ENABLE MORE FREIGHT TO BE MOVED BY RAIL. HELPING REDUCE CONGESTION ON OUR ROADS AND IMPROVING ROAD SAFETY.

ABOUT THE PROJECT

With one train able to move around the same amount of containers as 54 trucks, the Botany Rail Duplication will increase capacity on the Botany Line and wider Metropolitan Freight Network. This will encourage a freight transport mode shift from road to rail, which could result in a reduced rate of growth in truck movements and associated traffic congestion.

The Botany Rail Duplication will duplicate the remaining section of single line track, allowing freight to be moved efficiently from the port to our doorstep, and beyond.

Australian Rail Track Corporation (ARTC) is delivering the project on behalf of the Australian Government.

The tenders will now undergo a rigorous evaluation process, which will enable the

successful tender to be selected.

Botany Rail Duplication includes the following key features:

Track duplication – constructing a new track within the rail corridor for a distance of about three kilometres

Track realignment and upgrading - moving some of the track sideways to make room for the new track

New crossovers – constructing new crossovers to allow trains options to move between tracks

Bridge works – constructing new rail bridges at Mill Stream, Southern Cross Drive, O'Riordan Street and Robey Street, and re-constructing the existing bridges at Robey Street and O'Riordan Street

Embankment/retaining structures – constructing new embankment and retaining structures.

WHAT WE'VE BEEN DOING

In 2020, we've been getting on with project planning and achieved some key milestones:

- On 12 August 2020, the NSW Government announced State Significant Infrastructure (SSI) approval for the project to proceed, subject to conditions of approval.
- We've been progressing the procurement process for a design and construction contractor. Three shortlisted companies - John Holland, Laing O'Rourke and CPB Contractors have now submitted their tenders.
- The tenders are being evaluated by ARTC, with contract award anticipated to take place in mid-2021.
- We've also been carrying out utility investigations, site inspections and surveys, to help inform the project design.
