With respect to Condition C8, the required Construction Monitoring Programs for Noise & Vibration and Water Quality have been included in the respective CEMP Sub-Plans.

It is noted that:

- Previous versions of the documents have been reviewed and updated following comments from the ER.
- We know ARTC has also reviewed and commented on the documents.
- Following the above reviews the documents are considered to contain information required by the Conditions of Approval (SSI 9186) in relation to the CEMP and CEMP Sub-Plans.
