

NARRABRI TO TURRAWAN LINE UPGRADE

28 March 2022

Australian Rail Track Corporation (ARTC) is proposing to upgrade approximately 35 km of track between Turrawan and Narrabri to enhance the quality and capability of the connection between the Hunter Valley Network south of Turrawan and Inland Rail at Narrabri North and to provide a consistent service offering between Northern NSW, Inland Rail and the port of Newcastle.

By completing the 'missing link' between the Hunter Valley Network south of Turrawan and Inland Rail, it will help improve efficiency and allow an increase in the grain, cotton and freight volumes carried by rail.

Works would include the replacement of existing steel and timber sleepers with heavy duty concrete sleepers, replacement of the existing rail with upgraded rail, and earthworks.

Subject to approvals, delivery of the project is expected to start in mid-2022 and be completed by late 2023.

ARTC is currently preparing a Review of Environmental Factors (REF) to identify, assess and mitigate the potential environmental impacts associated with the proposed works. We are seeking community feedback on the Review of Environmental Factors (REF) for the proposed upgrade and welcome your comments.

The Review of Environmental Factors (REF) for the Narrabri to Turrawan Line Upgrade will be on exhibition between 5 April 2022 and 26 April 2022.


